### Turkey, France and Romania have started second phase of project



Senior programme officer B. Kesici, Project leaders G. Lehoux and A. Karslıoğlu opening the 4th twinning project steering committee in Ankara on May 25th.

During steering committee meeting at Hotel İlci, Ankara on May 25th, Deputy Director General B. Kesici restated the importance of the Twinning project and its results for SHGM. Major stakeholders involved in the project, French and Romanian Civil Aviation authorities, Expertise France, Turkish Central Finance and Contracting Unit, Ministries of transportation, of EU affairs as well as EU representation in Ankara and French Embassy representatives, acknowledged stocktaking of the first phase of the project (more than 242 expert days provided), and insisted on the need of precise follow up for project deliverables.

Workplan for March to June has been completed with 8 activities including 2 in France.
